## 1. INTRODUCTION

This document describes the supplementary requirements for the use of DCL Mark for Ready Mix Concrete Plants and Trucks certified under DM-DCLD-RD-DP21-2177(IC). These requirements shall be used in addition to the requirements of DM-DCLD-IMS-RD-13.

## 2. SCOPE

- 2.1 The below terms and requirements are applicable to all batching plants and their transport fleets covered under DCLD scope of certification.

## 3. TERMS FOR USE OF DCLD CERTIFICATE AND CONFORMITY MARK

- 3.1 Upon granting the DCLD Certificate of Conformity, the client (Ready Mix Plant) shall use the DCLD Plant and Truck Conformity Mark on all delivery tickets and the DCLD Truck Conformity Card shall be affixed on all delivery fleets covered by the scope of certification.
- 3.2 The use of DCLD Conformity Mark confirms that the company holds Dubai Municipality certification.
- 3.3 The design of the Plant and Truck Conformity Mark shall be in accordance with the illustration as shown in Annex (1) in line with DM-DCLD-IMS-RD-13. The design of the DCLD Truck Conformity Card (and its placement in the truck) shall be as per Annex (2).
- 3.4 The client shall discontinue the use of the DCLD Plant and Truck Conformity Mark and the DCLD Truck Conformity Card upon termination of the DCLD Certificate of Conformity.

## 4. REQUIREMENTS FOR THE USE OF THE MARK FOR BATCHING PLANTS AND DELIVERY FLEET.

- 4.1 The client may affix the DCLD Plant and Truck Conformity Mark to identify the certified batching plant(s) within the factory by any appropriate means (sign board, banner, plate, etc.).
- 4.2 The DCLD-DM Truck Conformity Card must be placed using laminated sheets to protect from moisture and dust on the windshield, or on the driver's side door (A4 size), in addition to a minimum of (A2 size) sheet to be placed on the external surface of the drum as shown in the examples in Annex 2 in line with DM-DCLD-IMS-RD-13 proportional size requirements, with the following information:
- Name of Company
  - Company Truck Number
  - Plate Number
  - DCLD Certificate Number
  - Validity

## 6. SUBMISSION, EVALUATION AND APPROVAL OF THE PROPOSED MARKINGS

- 6.1 The client shall submit to the DCLD-PCAS the proposed markings for evaluation and approval upon completion of the certification process.
- 6.2 The DCLD-PCAS approved markings shall be incorporated by the client in all batching plants and delivery fleet covered by the Scope of Certification.

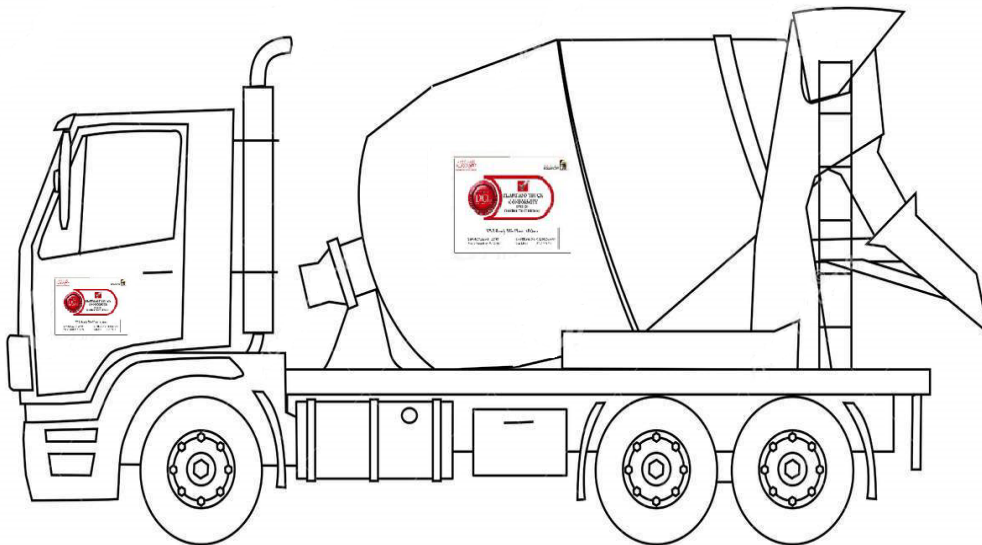
