1. PROCESS

This document gives details of the fees involved in the DM HALAL assurance certification as per RD-DP34-7101 (IC) "Specific rules for certification of organizations supplying Halal products in accordance with the UAE.S 2055-1 and DMS 032".

2. GENERAL DESCRIPTION

The fees are calculated based on the man-hours spent to carry out the required tasks given in the procedure, and multiplied by the official DCLD man-hour rate of AED 174/man-hour as provided for in DM Local Order 5/2001.

3. FEE CATEGORIES AND TERMS OF PAYMENT

All fees shall be paid to Dubai Municipality except those as mentioned in the table.
